Either <u>enclose a copy with your paperwork or email a photo</u> of both sides to epalmer@eptax.com. The same information is required for any children who are filing a return.

3. Worksheets for rental property or small businesses, are available at <u>www.eptax.com</u>. Please include those with your paperwork.

4. If there is an undergrad college student in the family, you must provide the <u>Form</u> <u>1098-T</u> from the college or university in order to qualify for the American Opportunities Credit.
